### Title: Suppliers Removed from the Infant Formula Supplier List

A review of the infant formula supplier list was recently completed, and several suppliers were removed from the list. Suppliers located in New York State that were removed were confirmed to be out of business (at the location listed) according to the Department of Agriculture and Markets. Out of state suppliers were removed if they were no longer listed on their state's infant formula supplier list.

Vendors that were using a supplier that was removed should begin using a new supplier that is on the current infant formula supplier list and inform their Vendor Management Agency of the change.
