Dear WIC Vendors,

Considering the recently issued Public Health Advisory by the Food and Drug Administration (FDA) for certain Similac, Alimentum, or Elecare brand's powdered infant formulas, the New York State WIC Program has received a Vendor Exchange waiver from USDA to allow vendors permission to make the following exchanges ONLY:

- Alimentum powder may be substituted for any can size of Alimentum powder
- 1 can (12.1 oz) Similac Alimentum Powdered Formula (SKU 070074647128) for 3 bottles (32 oz) Similac Alimentum RTU Formula (SKU 070074575131)

## Elecare and Elecare Jr. are not available in alternate can sizes or liquid forms and <u>cannot</u> be exchanged for another product.

As part of the recall exchange process, WIC authorized vendors are not required to, nor do we recommended that they, determine whether a product was purchased using eWIC benefits.

WIC authorized vendors must treat all customers the same with regard to the recall exchange process and possible substitutes (which may include, but are not limited to, the same product, a substitute product, store credit or a cash refund).
