Title: Discontinuation of Some Temporary Formulas

The United States Department of Agriculture (USDA) has granted NYS WIC an extension of the formula waiver (Medical Documentation for Food Packages I & II) which allows some alternative formula brands and sizes to remain on the APL until April 30, 2023.

However, some alternative products have been removed. The table below lists the alternative formula brands and sizes that have been removed, beginning March 1, 2023, from the Approved Product List (APL).
