NYS WIC PROGRAM VENDOR BULLETIN

Title: Discontinuation of Some Temporary Formulas

The United States Department of Agriculture (USDA) is transitioning back to normal program operations as nationwide supply chain issues improve. Substitute infant formula brands previously approved on a temporary basis in response to the formula shortage will be removed from the NYS Approved Product List (APL).

The table below lists the alternative formulas that will be removed from the APL on **June 1, 2023**.
